Signatures must be in longhand and in ink. Typewritten signatures will not be accepted. Any erasure marks must be initialed by executor of the bid.

Proposals shall be accompanied by a certified check, or satisfactory bid bond, made payable to or naming as obligee, North Londonderry Township in an amount not less than ten percent (10%) of the amount of the base bid. #### **CDL COMPLIANCE STATEMENT**

#### **ROAD MATERIALS**

### SUPERPAVE ASPHALT MIXTURE WEARING COURSE (Superpave 9.5 mm) IN PLACE, BITUMINOUS SEAL COAT AND BITUMINOUS SURFACE TREATMENT IN PLACE:


- 1. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, Superpave Asphalt Mixture Design 25 mm Base Course, Bituminous Seal Coat, or Bituminous Surface Treatment shall meet the current specifications of the Pennsylvania Department of Transportation. Material shall be furnished, delivered and placed by the contractor on any street as directed by the Township of North Londonderry authorities.
- 2. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, and Superpave Asphalt Mixture Design 25mm Base Course shall be produced from a state approved plant and shall be prepared from state approved material sources. The contractor shall furnish the Township of North Londonderry a certification stating that the materials meet the state specifications.
- 3. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, and Superpave Asphalt Mixture Design 25 mm Base Course, is to be delivered in trucks and placed in accordance with Pennsylvania Department of Transportation Standards. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, and Superpave Asphalt Mixture Design 25 mm Base Course is to be placed by means of self-propelled mechanical finishing machine.
- 4. The street or streets to be overlaid or surface treated are to be prepared and cleaned by the Contractor.
- 5. Should any of the Superpave Asphalt Mixture Design 9.5 mm Wearing Course be used on old macadam streets, it must be placed at a minimum depth of 1-1/4" (one and one-quarter inches). A tack coat must be applied for all overlays as specified in item 12 of these specifications.
- 6. All necessary labor, rolling, equipment and materials required in the furnishing, delivery and placing of the Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, Superpave Asphalt Mixture Design 25 mm Base Course, Bituminous Seal Coat, or Bituminous Surface Treatment is to be furnished by the contractor.
- 7. The contractor shall furnish and maintain all required barricades to completely close off newly paved streets until the bituminous concrete has cooled to a point so that normal traffic will not damage the surface.

#### **ROAD MATERIALS** (Continued)

- 8. The contractor shall furnish all necessary personnel for traffic control to maintain traffic flow in a safe manner around work areas as specified in Title 67, Transportation, Bureau of Highway Safety and Traffic Engineering, Chapter 212, Work Zone Traffic Control Publication 213.
- 9. The contractor shall furnish and install all necessary signing for work areas as needed per PennDOT specifications, and Title 67, Transportation, Bureau of Highway Safety and Traffic Engineering, Chapter 212, Work Zone Traffic Control Publication 213.
- 10. If required, the contractor shall apply the Superpave 9.5 mm, 19.0 mm or 25mm Bituminous Concrete in two courses with the first course at a depth as specified by North Londonderry Township Authorities on any street or any portion of a street.
- 11. The contractor shall familiarize himself with the contract form MS-944 (7-09) and will be required to execute the contract form MS-944 (7-09) including attachment "1", "2", "3" and "4" (MS-944S) (7-09) based on unit prices, prior to starting any work.
- 12. Tack coat shall be applied for all overlays. Contractor shall apply an asphalt tack coat over the entire surface to be overlaid. The tack coat material may be an asphalt emulsion of grade SS-1, SS-1h, CSS-1, or CSS-1h. The tack coat shall be applied with a distributor at the application rate of 0.08 gallons per square yard.
- 13. Wherever new paving comes in contact with old existing paving, the contractor shall notch existing pavement prior to completing the overlay.
- 14. The contractor shall install temporary pavement markings on roads having pavement markings which are overlaid or surface treated.
- 15. <u>COMPLETION DATE:</u> After notification by Township Authorities the contractor shall start work within ten (10) days of the date specified in the notice and shall complete the contract within thirty (30) days of the date specified in the notice. The notice shall give the contractor a minimum of two (2) weeks' notice.
- 16. Edge of cartway paving; the last three feet of paving adjacent to the curb shall be tapered toward the curb line.
- 17. The Contractor shall be responsible to blend residential driveways into the cartway at the discretion of and direction of North Londonderry Township Authorities.
- 18. The Contractor shall be responsible for defects that occur within two (2) years of application.
