## **INSTRUCTIONS TO BIDDERS**

Each person requesting specifications and bidding documents is furnished with one (1) complete set of documents as well as two (2) copies of the Proposal Form, two (2) copies of the Bid Bond Form, and CDL Compliance Statement. The two (2) copies of the Proposal Form and one (1) copy of the Bid Bond (if needed), along with the CDL Compliance Statement and PA Public Works Employment Verification Form shall be used to submit your Proposal.

Signatures must be in longhand and in ink. Typewritten signatures will not be accepted. Any erasure marks must be initialed by executor of the bid.

Proposals shall be accompanied by a certified check, or satisfactory bid bond, made payable to or naming as obligee, North Londonderry Township in an amount not less than ten percent (10%) of the amount of the base bid. Guarantee checks or bid bonds shall be forfeited as liquidated damages if the bidder fails to execute the contract and furnish bonds as specified, within fifteen (15) days after notification of the contract award.

The Proposal must be physically received in the Township Office by 10:00 a.m. prevailing time, March 7, 2024. Proposals presented after 10:00 a.m. will not be received or accepted. The Proposals will be publicly opened and read at 10:00 a.m. prevailing time, March 7, 2024, and considered for award at the meeting of the North Londonderry Township Board of Supervisors on March 18, 2024, beginning at 7:30 p.m. prevailing time.

The Proposal must be signed by an owner, partner, or in the case of a corporation by the President or Vice President and attested by the Secretary, with the corporate seal affixed thereto. If signed by any other corporate officer, a power-of-attorney must be attached to the bid.

The contractor/supplier shall have the right to increase the contract unit price of the bituminous items in accordance with PennDOT Publication 408, Section 110.04. Any increase (or decrease) in the contractor/supplier's cost of such item after the bid date shall be verified by the proper documents furnished to the Township of North Londonderry, including Proof of Price to contractor/supplier from the contractor/supplier's source of supply.

Should the contractor/supplier's allocation of any item be materially reduced by the contractor/supplier's source of supply, the contractor/supplier may reduce proportionately the quantity of such item to be delivered in accordance with this contract.

Accompanying this proposal is a certified check or bid bond payable to North Londonderry Township in the amount of ten percent (10%) of the bid, as a proposal guarantee which, it is understood, will be forfeited in the event the contractor is awarded the contract and fails to provide the necessary performance bond, as required.

The municipality may withdraw or reduce the quantity of any item or terminate or reduce the scope of the contract if the unit cost of any item is increased more than ten percent (10%) above the bid.

If written notice of the acceptance of this bid is mailed, telegraphed or delivered to the undersigned within forty-five (45) days after the date of opening of the bids, or anytime thereafter before this bid is withdrawn, the undersigned will, within fifteen (15) days after the date of such mailing, telegraphing or delivering of such notice, execute and deliver a contract in accordance with specifications and bid as accepted. Along with the contract delivery, the successful bidder shall submit a guarantee of performance in terms of the contract in the form of a bond or certified check payable to North Londonderry Township in the amount of one hundred percent (100%) of the bid. If a certified check is submitted, it will be forfeited to North Londonderry Township to cover any added costs to the Township in the event it determines by written notice to the contractor that any equipment was not available when needed or that its performance was unsatisfactory.

**CDL COMPLIANCE STATEMENT**

The Parties to this contract agree the relationship between the Contractor and the Township is one of independent contractor and not employer/employee and that the individual employees of the Contractor who will be performing the work pursuant to this Contract are not employees of the Township. The Contractor hereby certifies, represents, and warrants to the Township each person performing any aspect of the work pursuant to this Contract who are required to have a commercial driver’s license: (1) are in a program for drug and alcohol testing in accordance with the Federal Omnibus Transportation Employee Testing Act of 1991 and the federal regulations adopted pursuant thereto and (2) hold a valid Commercial Driver’s License.

Due to the nature of the work that the Contractor may perform for the Township, the Contractor must use employees who perform safety-sensitive functions for which a Commercial Driver’s License (CDL) is typically required. Section 382.301(d)(2) of the Federal CDL Regulations requires that, prior to being awarded any contract by the Township, and every six (6) months of the Contract, the Contractor must certify that it remains in a qualified CDL drug and alcohol testing program.

If the Contractor is not participating in a qualified CDL drug and alcohol testing program at the time of the awarding of the Contract, or at any six (6) month re-certification point, then all the Contractor’s CDL employees must obtain a negative result on a pre-employment drug test before beginning (or continuing) contracted work for the Township at the expense of the Contractor.

## **ROAD MATERIALS**

### **SUPERPAVE ASPHALT MIXTURE WEARING COURSE (Superpave 9.5 mm) IN PLACE, BITUMINOUS SEAL COAT AND BITUMINOUS SURFACE TREATMENT IN PLACE:**

1. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, Superpave Asphalt Mixture Design 25 mm Base Course, Bituminous Seal Coat, or Bituminous Surface Treatment shall meet the current specifications of the Pennsylvania Department of Transportation. Material shall be furnished, delivered and placed by the contractor on any street as directed by the Township of North Londonderry authorities.
2. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, and Superpave Asphalt Mixture Design 25mm Base Course shall be produced from a state approved plant and shall be prepared from state approved material sources. The contractor shall furnish the Township of North Londonderry a certification stating that the materials meet the state specifications.
3. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, and Superpave Asphalt Mixture Design 25 mm Base Course, is to be delivered in trucks and placed in accordance with Pennsylvania Department of Transportation Standards. The Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, and Superpave Asphalt Mixture Design 25 mm Base Course is to be placed by means of self-propelled mechanical finishing machine.
4. The street or streets to be overlaid or surface treated are to be prepared and cleaned by the Contractor.
5. Should any of the Superpave Asphalt Mixture Design 9.5 mm Wearing Course be used on old macadam streets, it must be placed at a minimum depth of 1-¼" (one and one-quarter inches). A tack coat must be applied for all overlays as specified in item 12 of these specifications.
6. All necessary labor, rolling, equipment and materials required in the furnishing, delivery and placing of the Superpave Asphalt Mixture Design 9.5 mm Wearing Course, Superpave Asphalt Mixture Design 19.0 mm Binder Course, Superpave Asphalt Mixture Design 25 mm Base Course, Bituminous Seal Coat, or Bituminous Surface Treatment is to be furnished by the contractor.
7. The contractor shall furnish and maintain all required barricades to completely close off newly paved streets until the bituminous concrete has cooled to a point so that normal traffic will not damage the surface.

## ROAD MATERIALS (Continued)

8. The contractor shall furnish all necessary personnel for traffic control to maintain traffic flow in a safe manner around work areas as specified in Title 67, Transportation, Bureau of Highway Safety and Traffic Engineering, Chapter 212, Work Zone Traffic Control Publication 213.
9. The contractor shall furnish and install all necessary signing for work areas as needed per PennDOT specifications, and Title 67, Transportation, Bureau of Highway Safety and Traffic Engineering, Chapter 212, Work Zone Traffic Control Publication 213.
10. If required, the contractor shall apply the Superpave 9.5 mm, 19.0 mm or 25mm Bituminous Concrete in two courses with the first course at a depth as specified by North Londonderry Township Authorities on any street or any portion of a street.
11. The contractor shall familiarize himself with the contract form MS-944 (7-09) and will be required to execute the contract form MS-944 (7-09) including attachment "1", "2", "3" and "4" (MS-944S) (7-09) based on unit prices, prior to starting any work.
12. Tack coat shall be applied for all overlays. Contractor shall apply an asphalt tack coat over the entire surface to be overlaid. The tack coat material may be an asphalt emulsion of grade SS-1, SS-1h, CSS-1, or CSS-1h. The tack coat shall be applied with a distributor at the application rate of 0.08 gallons per square yard.
13. Wherever new paving comes in contact with old existing paving, the contractor shall notch existing pavement prior to completing the overlay.
14. The contractor shall install temporary pavement markings on roads having pavement markings which are overlaid or surface treated.
15. COMPLETION DATE: After notification by Township Authorities the contractor shall start work within ten (10) days of the date specified in the notice and shall complete the contract within thirty (30) days of the date specified in the notice. The notice shall give the contractor a minimum of two (2) weeks' notice.
16. Edge of cartway paving; the last three feet of paving adjacent to the curb shall be tapered toward the curb line.
17. The Contractor shall be responsible to blend residential driveways into the cartway at the discretion of and direction of North Londonderry Township Authorities.
18. The Contractor shall be responsible for defects that occur within two (2) years of application.

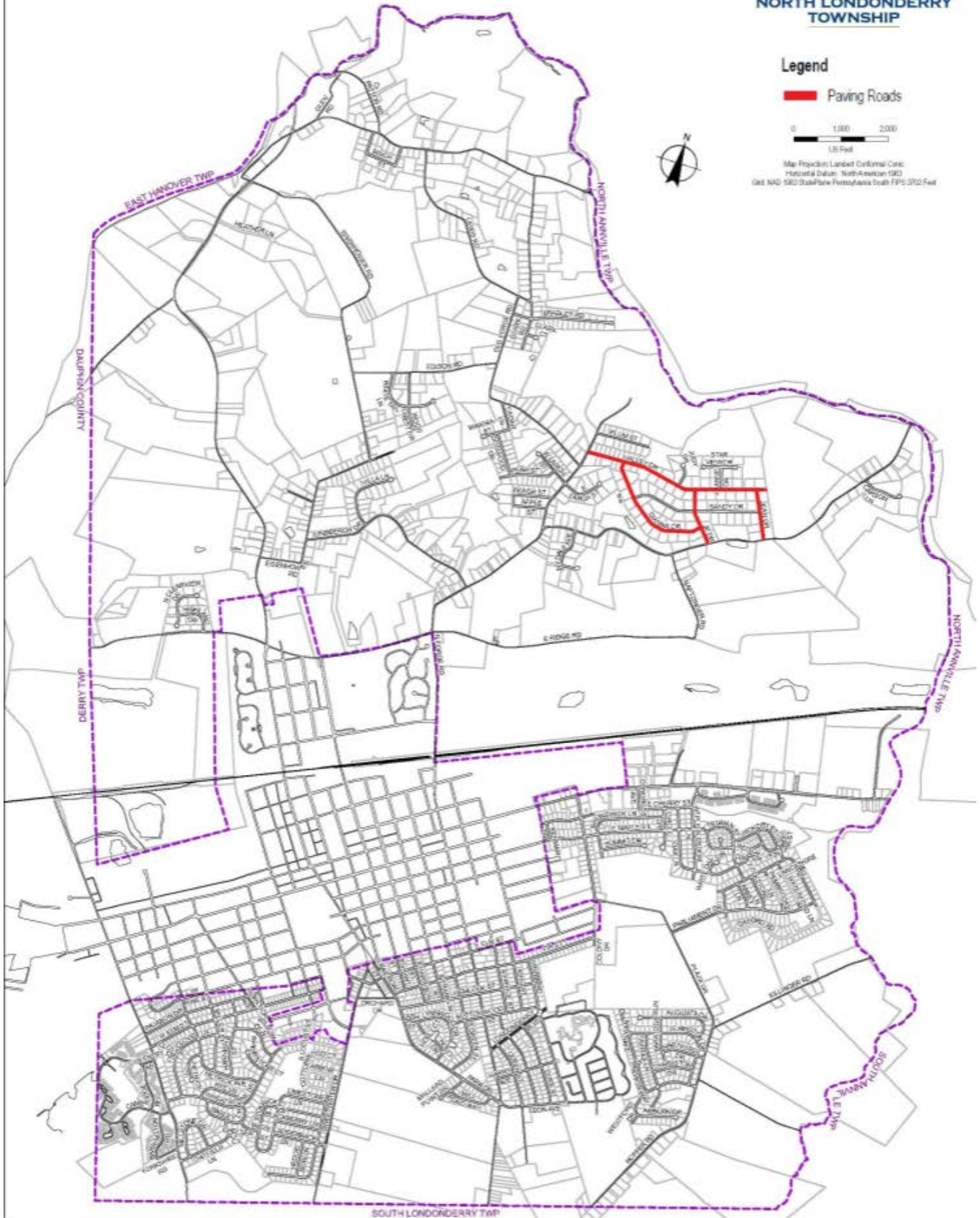
